As England prepares to enter a second period of lockdown, A&P can confirm that A&P Tyne, A&P Tees and A&P Falmouth will remain in full operation.

ANY PERSONNEL WHO IS FOUND TO BE PRESENTING/OR HAS PRESENTED WITH A HIGH TEMPERATURE OR NEW AND CONSISTENT COUGH WITHIN THE LAST 14 DAYS WILL NOT BE ADMITTED ON SITE.**
- **ANY PERSON WHO HAS BEEN IN DIRECT CONTACT WITH A KNOWN OR SUSPECTED COVID-19 PATIENT WITHIN THE LAST 14 DAYS MUST NOT ATTEND SITE.**
- **DIRECTORS’ SAFETY TOURS ACROSS ALL SITES TO GAIN FEEDBACK TO IMPROVE OUR DAILY WORKING PRACTICE AND PROTECT OUR WORKFORCE.**
- **STRICT TWO METRE SOCIAL DISTANCING REQUIREMENTS ON SITE.**
